

# Activities Report & Cash Flow Statement

For the 3 months ending 30 June 2021



MCS Services Limited (**MCS Services**) (**Company**) (ASX: **MSG**) is pleased to present its Activities Report and Appendix 4C for the three months ending 30 June 2021 (**Period**).

During the Period the Company recorded a net cash inflow of \$634,000, finishing the Period with a cash balance of \$4,663,000 (31 March 2021: \$4,029,000).

Cash and net receivables/payables as at 30 June 2021 totaled \$4.5 million (\$4.0 million as at 31 March 2021) comprising cash of \$4.6 million (\$4.0 million as at 31 March 2021) and net payables of \$0.1 million (\$0.01 million net receivables as at 31 March 2021).

## **OPERATIONS UPDATE**

During the Period the Company:

### **Uniformed Security:**

- Announced the renewal of its security contracts with the owner of three major Perth shopping centres.
- Benefitted from increasing levels of revenue from its work in the WA hotel quarantine system and, separately, from its Health Service Security work (primarily that from the NMHS contract commenced in December 2020, as announced on 29 January 2021). Whilst the Company was recently disappointed to not have its (\$1.1 million revenue pa) contract renewed for a portfolio of two Perth shopping centres (as the client moved to an integrated facilities service model), the revenue from the Health Service Security work alone is tracking to exceed that from those Centres.
- Further progressed tenders lodged with a number of renowned Shopping Centre owners for their multi-site / multi-year portfolios. Announcements on those tenders are anticipated shortly.

### **Alarm & CCTV:**

- Continued to expand its market for the installation, maintenance and monitoring of CCTV and alarm systems at shopping centres, aged-care facilities and hotel chains in WA and the Northern Territory;

## **COVID - 19**

The operational and commercial impacts on the Company remain as advised in the previous Period and the announcement to shareholders on 2 December 2020, including:

### **Retail Security:**

- The recent short-term 'lockdowns' in the Perth and (adjacent) Peel regions of WA (1 - 5 February 2021, 24 - 26 April 2021 and 29 June - 2 July 2021) had no material effect on work volumes.

### **Quarantine Security:**

- Commencing in April 2020 the Company has been providing security at one Perth hotel utilised for COVID isolation. This work cushioned MCS Services' revenue from the reduced Retail Security work during the initial period of COVID restrictions in WA, being primarily in the June 2020 Period. The Company utilises a specialist roster of security staff, operating to protocols and PPE requirements developed in line with regulatory requirements and guidance.

As at the date of this Report the Company continues to provide services at the same hotel. The continuation / volume of the Company's work going forward is subject to a number of factors including Government policy, quarantine regulations and incoming flight levels.

**Events Security:**

- During the Period the Company has undertaken a number of community and sports-related security roles in WA, though not yet to pre-COVID levels.

**GROWTH OPPURTUNITIES**

The Company has security operating licenses for Western Australia, South Australia, Victoria, South Wales, ACT and, recently, Queensland.

During the Period the Company commenced covert (plain-clothed store-based staff) security for a national retailer at stores in South Australia, complementing a similar existing service provided in its WA stores.

The Company continues to seek further organic growth opportunities in its specialist security segments, including but not limited to leveraging its reputation with existing clients to obtain work at additional locations. The Company is also assessing the addition of new verticals to its business.

The Company is constantly assessing the expansion of its operations in the Perth metropolitan area, regional Western Australia and interstate through the identification and acquisition of suitable targets. It may progress these opportunities if they are value accretive to shareholders and consistent with the Company's strategy.

The Company continues to actively review and enhance it's marketing strategy.
